

# **Minutes of the PPG Meeting Held at Thornley Medical Centre, Thornley Street, Hyde, SK14 1JY 30 May 2013**

## **1. Welcome:**

The Chair welcomed everyone to the meeting.

Ingrid pointed out that there are pressures of the number of requests for guests to attend the PPG meetings means there is very little time to discuss patient-specific issues. She suggested that our PPG has extra evening meetings (6 – 7pm) for those who are unable to attend during the day.

## **2. Minutes of the Last Meeting:**

The minutes were agreed as being correct.

- 3. Dept of Nursing, MMU linkup: Jacqui Gladwin, Principal Lecturer, MMU and James Garney** spoke about the internet social network (not Facebook) they have developed for their nursing students. In order to facilitate a better experience for their new students they are giving the option of creating 'Nursing buddies' with patients and carers. They are offering HTMC patients and carers the option of signing up (a pseudonym can be used) so that they can have a private conversation with the student nurses about their medical condition. Jacqui will put together an 'info page' inviting people to join. Dr Hannan offered to have a session to show people how to sign up if they wish.
- 4. iPhone/AndroidApp for anti-biotic prescribing: Saarah Naizi-Ali (CCG Pharmacist)** is looking to recruit 60 patients to act as controls for her research into *Clostridium difficile*.

She also spoke about a mobile phone App she has developed on Antibiotic prescribing. The App is available to both professionals and patients and is already available to download from Tameside NHS. It is both a decision tool for health professionals and for patients to consult as to whether they need to go to the doctor or not for antibiotics.

Saarah will write a letter of introduction and request to be sent to all HTMC patients signed up for emails.

## **5. Record Access Problems**

At the previous meeting Dominic Sexton invited members to email him with any difficulties accessing the HTMC Record Access site. Yvonne said that she had informed him of her difficulties. Further complaints about access have been received by Amir Hannan, including problems accessing Test Results

Rob Murgatroyd has left the company and Tim East is now managing patient access to records. Amir pointed out that EMIS receives no funding for this service. However, it was proposed that a letter is sent from the PPG group to EMIS and to the System Provider itemising problems.

**Note:** The EMIS web is now available in Tameside Hospital A&E and the Medical Assessment Unit.

Amir circulated a document 'Gita' to PPG members prior to the meeting highlighting **Urgent Care**. Time limits meant this was not discussed at the meeting.

## 6. HealthWatch Tameside

There was a HealthWatch Tameside meeting in Dukinfield Town Hall but no one from the PPG was able to attend. They are looking for a Chair (unpaid position).
